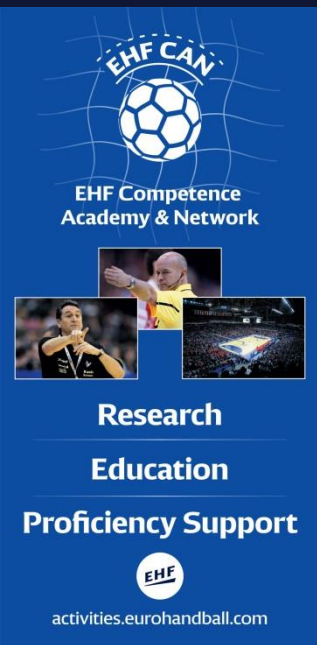

- ◆ EHF CAN = Network of EHF Commission Members, EHF Lecturers, National Federation and external experts
- ◆ Unanimous adoption at the 2008 EHF Congress
- ◆ 2009 – 2014 EHF CAN activities – 5th anniversary -“YES, WE CAN”
- ◆ Technical Delegation / EHF CAN Advisory Board
- ◆ Coordination on EHF Office level (all departments)
- ◆ EHF CAN budget = part of the EHF Development budget

What kind of EHF certification and licensing do we have?

- ◆ RINCK Convention(RC) – 4 categories (4 = EHF Master Coach)
- ◆ PRO Licence (EHF Master Coach + EHF involvement/thesis)
- ◆ EHF Coaching Licence (RC Category 3)
 - mandatory in all EHF Club and National Team Competitions as of the 2014/15 season (transition period with regular and temporary licences)

- ◆ Referees – EHF Young Referee Badge, EHF Referee Status
- ◆ Delegates – Selection, Training/Testing, EHF Delegate Status
- ◆ Club Managers – EHF Club Manager Licence
- ◆ Beach Handball – EHF Referee, Delegate and Coaching Diploma

Which kind of technical, technological and educational cooperation do we have with other Team Sport Federations, Universities and the EU?

- ◆ EHF is a member of the MESGO Programme run by UEFA
- ◆ EHF is cooperating with former FIBA Europe Techno Centre experts on Gran Canaria
- ◆ EHF has an agreement with the University Las Palmas (ULPGC)
- ◆ EHF is cooperating with the German Sport University Cologne
- ◆ EHF application option for EU Projects Erasmus+ (up to 2020)

Which projects have been carried-out by the EHF/EHF CAN recently?

- ◆ EHF Member Federation participants in the MESGO programme (DEN, LAT)

- ◆ EHF involvement in EU projects “Sport4GoodGovernance” and “EOSE”
- ◆ EHF usage of Referee Observer Programme/On-line Platform and Digital Scoresheet developed by University Las Palmas for EHF EURO Events

- ◆ EHF referee video teaching material, 2D and 3D animated promotion web tools for Minihandball and Handball at School developed by the University Las Palmas

- ◆ EHF Cooperation with equipment suppliers - top goals produced and serviced by HUCK Poland

Which projects are planned in the near future?

**“European Master of Handball Coaching
in Europe” (academic title)**

- ◆ EHF Cooperation with the ULPGC (University Las Palmas) on the Certification of EHF Master Coach Education in terms of the EU Educational System (Bologna process) by awarding ECTS (Education Credit Transfer System) points to all “University related” Master Coaches

EHF- University Las Palmas Master Coach Certification Project

Two different Academic Certifications according to academic qualifications of candidates:

1) European Master Degree: for students with a University Degree

EU countries:

notarized copies of University Degrees translated into English/Spanish have to be provided

Non-EU countries:

copies of University Degrees translated into English/Spanish as well as a conformation from the university about the “proper knowledge/ education” of the candidate have to be provided

EHF- University Las Palmas Master Coach Certification Project

2) Quality Certification Training Program: **for students who do not have a University Degree**

Copies of high school diploma, a written confirmation (stamp and signature) of fulfilling the Federation or Institutional requirements for Categories II and III in terms of EHF RINCK Convention have to be provided

For the correct recognition of the EHF RINCK Convention System an academic commission consisting of handball experts with academic background will be formed for analysing all applications!

EHF- University Las Palmas Master Coach Certification Project

System for the Recognition of credits earned in each Category:

Category II- 18 ECTS

Category III-20 ECTS

IV (Master Coach) includes 16 ECTS of theoretical / practical teaching plus Master Final Project with at least 6 ECTS. All together (18 + 20 + 16 + 6) will reach 60 ECTS as the level of Master

Concerning the Master Final Project (6 ECTS), formal requirements (structure, conditions) will be laid down by the University (Scientific research in cooperation with the EHF recognized Handball coaching experts required)

“European Handball Managers”

- ◆ EHF cooperation with the German Sport University Cologne (DSHS Köln) on the implementation of a 12 month University Course (as of the 2015/16 season)

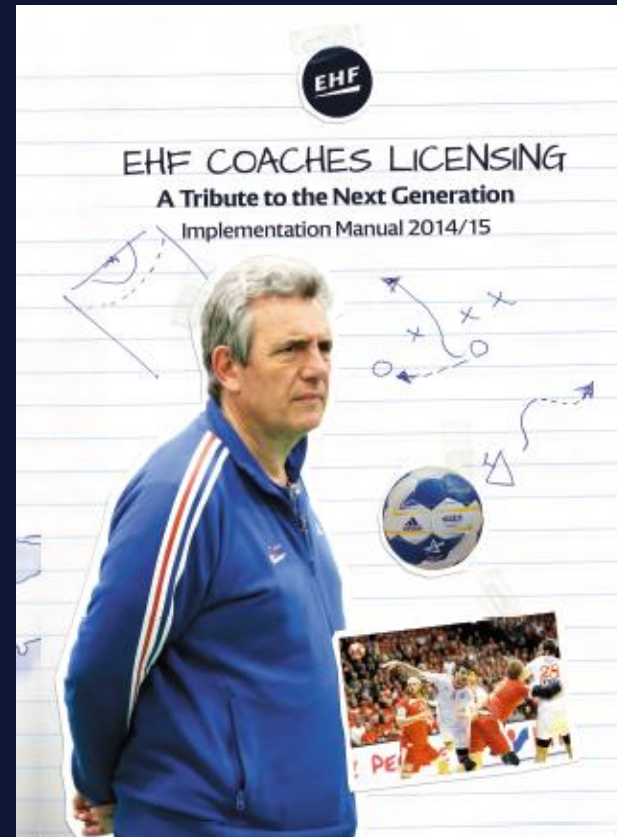
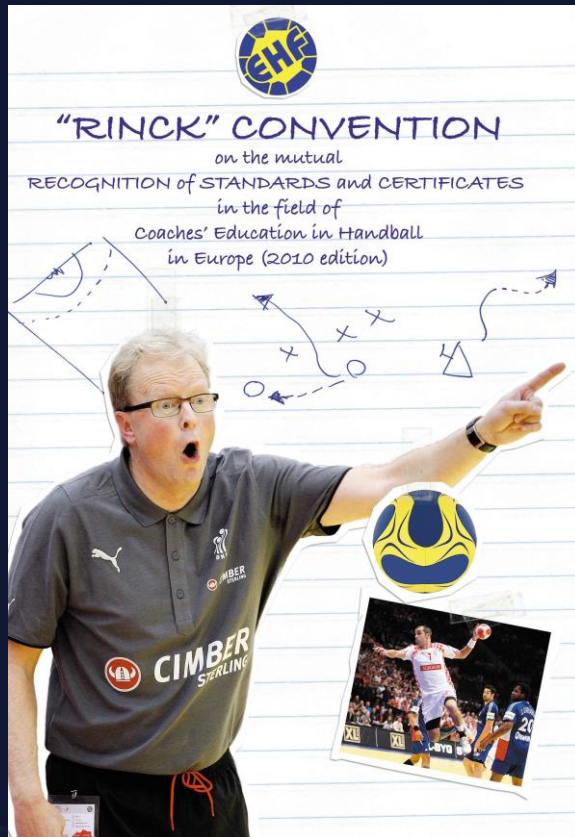

2014/15 EHF Coaches Licensing

- EHF EXEC Decision 9/2013 (MC proposal)
- Implementation as of the 2014/15 season in all EHF competitions (club and national team)
 - Transition period – exemptions as defined
 - (at least) “1 licenced Coach per Team” principle
 - Competition-related Licensing per season
- Adaptation of the 2014/15 EHF Competition Regulations

2014/15 EHF Coaches Licensing

- EHF RINCK Convention Level/Category 3 (or higher) – exemptions as defined
- Registration via EHF Coaches Licensing Application Sheet in addition to Players' List approved by the National Federations
- Coaches from clubs or national teams from the RINCK Convention Category 2 signatories or non-signatories must have the highest national coaching level (to be confirmed by the respective National Federation) and shall receive a temporary licence by EHF after submitting their coaching career CV to EHF (EHF coaches' Education Form).
- Check and approval by National Federations parallel to Players List approval in accordance with competition/phase registration deadlines
 - Cooperation EHF – National Federations

2. Registration – EHF Coaches Licensing Application Sheet

- EHF Coaches Licensing Application Sheet to be filled-in by the club / NAT
- EHF Coaches Licensing Application Sheet to be confirmed and submitted to the EHF by the NAT (Compare Annex 1)

3. DEL Reporting

Obligatory remark by the EHF delegate on the match report if the licensed coach is not among the officials.

- Administrative follow-up with clubs and NAT by EHF
- Flexible handling in the transition period 2014/15

4. EHF Coaching Licences - Validation Period

EHF Pro Licence (2+2 years)

Renewal by attending IHF Coaching Course, EHF Top Coaches Seminar, National Coaches' Clinic with EHF/IHF Lecturers

EHF Coaching Licence (limited to the respective competition/ season)

Renewal by new registration/ confirmation for the respective EHF competition/ season
