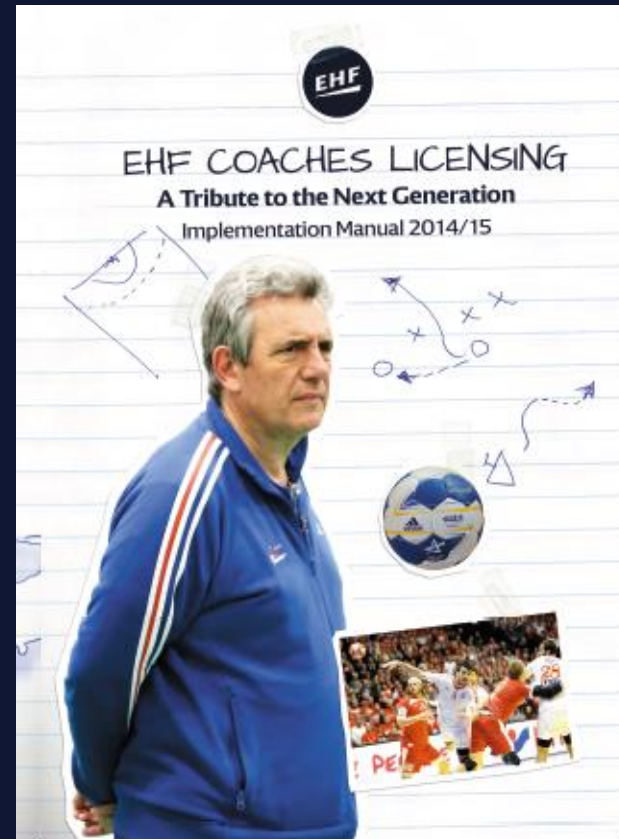
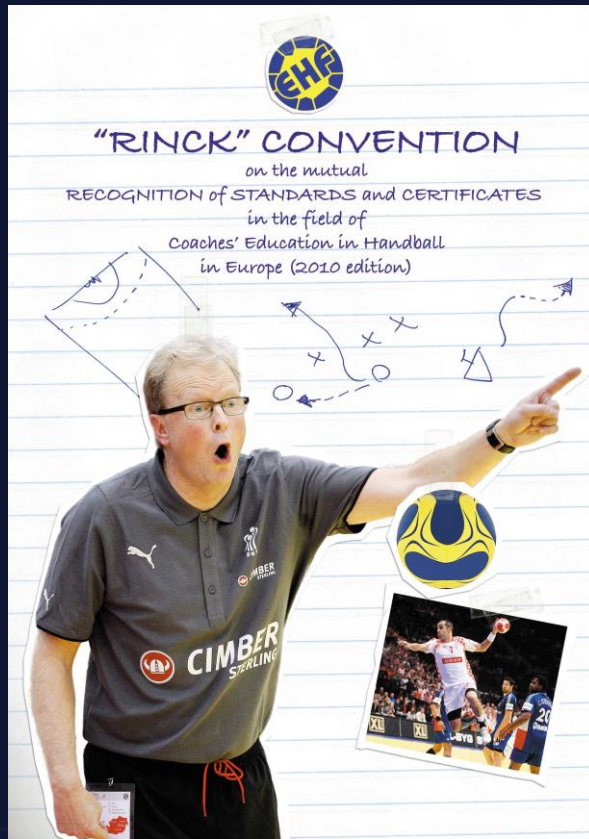

# **Transition Period Exemptions**

**Transition period solutions (temporary licences) up to the 2015/16 season**

- **Minimum Requirement RC Category 3 (=EHF Coaching License) for Category 3**

**Signatories and RC Category 2 for Category 2 Signatories (= highest national coaching education)**

- **YAC National Team Competitions Men and Women: temporary licence for young coaches in the 2014/15 season - obligatory as of 2015/16\***

**\*1 more year for individual educational update on national level**

- **EHF RINCK Convention Level/Category 3 (or higher)  
in all EHF Competitions – exemptions as defined**
- **Registration via EHF Coaches Licensing Application Sheet / EHF  
Coaches’ Education Form in addition to Players’ List approved by the  
National Federations**
- **Check and approval (stamp&signature) by National Federations  
parallel to Players’ List approval in accordance with competition/phase  
registration deadlines**
- **Administrative cooperation EHF – National Federations**

**EHF- University Las Palmas Master Coach Certification Project**

Two different Academic Certifications according  
to academic qualifications of candidates:

**1) European Master Degree: for candidates with a University Degree**

**EU countries:** notarized copies of University Degrees translated into English/Spanish have to be provided

**Non-EU countries:** copies of University Degrees translated into English/Spanish as well as a conformation from the university about the “proper knowledge/ education” of the candidate have to be provided

**EHF- University Las Palmas Master Coach Certification Project**

**2) Quality Certification Training Program: for candidates who do not have a University Degree**

**Copies of high school diploma, a written confirmation (stamp and signature) of fulfilling the Federation or Institutional requirements for Categories II and III in terms of EHF RINCK Convention have to be provided**

**For the correct recognition of the EHF RINCK Convention System an academic commission consisting of handball experts with academic background will be formed for analysing all applications!**

**EHF- University Las Palmas Master Coach Certification Project**

**System for the Recognition of credits earned in each Category:**

**Category II- 18 ECTS**

**Category III-20 ECTS**

**IV (Master Coach) includes 16 ECTS of theoretical / practical teaching plus Master Final Project with at least 6 ECTS. All together (18 + 20 + 16 + 6) will reach 60 ECTS which complies with “Master” Title in EU Bologna system**

**The criteria of the Master Final Project (6 ECTS) /formal requirements (structure, conditions) will be laid down by the University (Scientific research in cooperation with the EHF recognized Handball coaching experts)**
