"As of the season 2014/15 all clubs and national teams taking part in EHF competitions, including European Cup Competitions, Champions League, EURO Qualifications and EURO Events (Senior and YAC) shall be obligatorily coached by licensed coaches corresponding to category 3 of RINCK Convention (as a minimum)."





Coaches from clubs or national teams from the RINCK Convention Category 2 signatories or non-signatories must have the highest national coaching level (to be confirmed by the respective National Federation) and shall receive a temporary licence by EHF after submitting their coaching career CV to EHF (EHF coaches' education form).
