Competition Manager

Is responsible for the correct implementation of the competition infrastructure and the competition in accordance with the applicable regulations and guidelines in cooperation with the tournament management.

- Enforcement of EHF competition requirements (including optical appearance)
- Meetings (preparatory, tournament management, OC)
- Enforcement of EHF procedures and guidelines
- Enforcement of infrastructure and requirements in the triangle OC-EHF Partners-EHF
- Game Administration tasks during the tournament/matches







(in agreement with the tournament management, the EHF representatives on the venue and the EHF venue manager)

- Basic operation of the venue together with the EHF venue manager
- Trouble shooting in cooperation with the tournament management, the EHF representative and the EHF venue manager







Tournament management:

Fields of function:

To take care of issues relating to the entire event. Is the highest body with regard to the individual event.

- Meetings with the Organizing Committee during the event
- Daily business coodination with all venues
- Decisions on open tournament matters

Local tournament management:

Fields of function: (in agreement with the EHF Tournament Management)

Responsible for the correct operation of the competition at the venue

- Finalization/supervisation of venue set-up
- Meetings with the LOC during the event
- > Daily business operation and decitions at the venue
- Final report after the tournament







(in agreement with the tournament management, the EHF representatives on the venue and the EHF venue manager)

Playing Arena:

Basic/separate set-up responsiblity defined

- > The arena will be ,handed over' to you at a certain status of completion
- Further implementation of measures after the departure of the set-up team to be guaranteed:
 - o to-dos?
 - special solutions
 - o special programme?
- ➤ Obligation to report to the tournament management immediately in case certain measures are refused repeatedly by the OC

Competition responsible at the venue:

Fields of function: (in agreement with the EHF Tournament Management, the competitions manager, the EHF representative and the EHF venue manager)

To keep control over the implementation of the detailled task at the venues

- Contact to EHF Competition Management and compentition manager
- Contact to LOC Competition Management
- Securing a correct Competition Infrastructure according to Rules and Regulations
- Venue Set-up check prior and during the competition
- > Preparatory activities responsible: Key personnel meeting, test match...
- Tecnical meeting

Competition responsible at the venue:

Meetings and Test Match:

- Key personnel meeting
- Security meeting
- Technical meeting
- Test Match
- Feedback meeting
- Tournament Management/OC







Competition responsible at the venue:

Implementation of EHF procedures and guidelines:

- Training with stakeholders (mascots, entry kids, mopping crew, etc.)
- Minus 30/minus15 count down prior to each match (lasting until throw off)
- Coordination throw off with TV floor manager
- Procedure before, during and after the game
- Run down for the game (warm-up, line-up)
- Training match report system and refereeing scouting;
- Match report handling (EHF, Swiss Timing, LOC)
- > TV floor manager, flash/mixed zone cooperation
- Post-match press conference/media cooperation

Refereeing responsible and observer at the venue:

Fields of function: (in agreement with the EHF Tournament Management, the competitions manager, the EHF representative and the EHF venue manager)

The coordination of all issues and activities relating to the nominated referees, their preparation, guidance, activities...

- Daily meetings with interactive stucture using videos/match sequences...
- Coordination of daily physical activities for referees
- Individual feedback and analysis
- Daily contact between referees and observers to be reported to central refereeing responsible
