## What are his tasks ?

Picking up the match report in the CPO is the first step of your job in a match, remember to take a raw copy for yourself.

The playing court is now your home: it has to be free from any objects





Checking the secretary table will be as well important: reserve clock, suspension cards, whistle, TTO cards ( to be delivered to team officials).....





Positions in the secretary table will be important for a better cooperation among all officials: looking the court on the right side Delegate, Timekeeper in the middle , Scorekeeper on the left side.





During the match  
Timekeeper has the duty of  
clearly indicating the  
number of points and the  
shirt number of the scorer,  
whistle for TTO,  
Scorekeeper indicates to  
referees the number of the  
suspensions (with cards).



## And the Delegate ?

Final responsibility for time running and score is on him. None of these duties is on referees. Attention on what is happening has to be at the top level, control on TK and SK job **MUST** be constant.







Delegates always have to  
support referees....





When everything will be in order and under control then it will be the time for some conversation with the team officials of both teams ( spend almost same time with them) about “fair play” and for any clarification they need and might be useful for a fluent game.







## During the match.....

- Visual contact with referees
- How to check the regular development of match report? Make one by yourselves and interrupt immediately the match if there is any discrepancy with official MR
- Take notes about what is going on in the court

## During the match.....

- Control on both substitution areas is mainly a Delegate job , in fact , due to the very fast evolution of the game , is difficult for referees to do it ; but same opportunities must be given on both sides of the court, considering the distance from your position.





## After the match.....

- Deliver and get back the "referee's evaluation" paper to both teams
- Check the match report , sign it together with Timekeeper, Scorekeeper and Referees ONLY when everything is correct
- Take it to the CPO tent





## After the match.....

- Now is “referees time” : the most important moment for education and development of our referees
- Choose the right way to express your ideas, your feelings and vision about the match and the progressive line.





## After the match.....

This is not the “punishment” moment but the “tutorial” moment , let them express their sensations , give them clear points for a discussion describing the situations that you have noted on your papers







## How to manage a protest:

- Protests shall be announced to the EHF delegate orally after the end of the match
- The reason of the protest shall be handed over in writing within 30 min after the end of the match. At the same time a protest fee of 400€ has to be paid. If the protest is accepted the deposit will be refunded.
- The EHF Disciplinary Commission takes its decision by a simple majority 1h before the start of the next match of the team concerned
- All decisions taken by the Disciplinary Commission (1stand 2ndinstance) are final decisions.
